4. How to Enter the Contest: During the contest Submission Phase, Instagram users that follow the @sizzlerusa handle on Instagram can tag (1-3) friends/family that they believe will be interested in Sizzler's content. In the comment section of a Sizzler's post during the promotion period, users will be encouraged to tag their friends/family. Each user and tagged user must do the following to be considered as an entrant into this promotion:

1. Like Sizzler's post
2. Follow Sizzler's Instagram page

In addition, the user who tags their friend and the friends that are tagged in the comment will be automatically entered into a sweepstakes to win a \$50 Sizzler gift card at the end of each month.
